Players will be grouped by age and ability at the beginning of each camp.

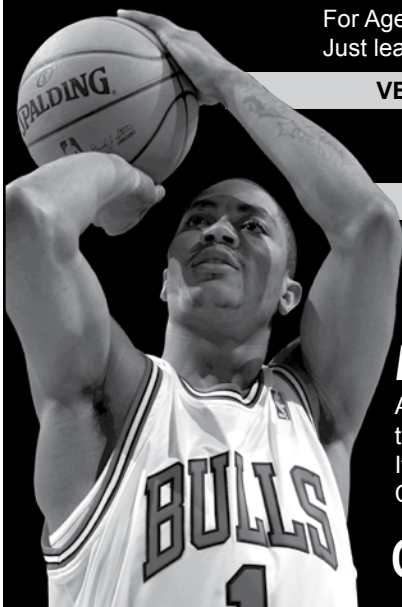
### BULLS SKILLS COMPETITION
